The Commission will notify the public as to when EDGAR will begin accepting the 2020 taxonomies and no longer accept the “invest” taxonomies, and subsequently, when it will no longer accept a taxonomy version with a double strike-through in the table above. For reference purposes, taxonomy versions in gray and a single strike-through will have already been deleted from EDGAR in an earlier release.

Note that the taxonomies are independent of one another; the following is an exception:
