1 Overview

The 2021Q4 release includes the first publication of the Closed-End Fund (cef) taxonomy for acceptance in EDGAR and an update to the Document and Entity Information (dei) taxonomy to provide new elements to tag auditor information. The table below contains all of the current taxonomy versions accepted in EDGAR beginning December 2021.

The Commission is notifying the public that EDGAR is now accepting the cef-2021q4 and dei-2021q4 taxonomies. For reference purposes, taxonomy versions in gray and a single strike-through will have already been deleted from EDGAR in an earlier release.

1.1 Consolidation of Taxonomy Files

Prior to the 2021 versions of the taxonomies listed above, every SEC-maintained eXtensible Business Reporting Language (XBRL) taxonomy contained several schemas with element, type and role declarations, empty schemas having only linkbase pointers ("entry points") and linkbases that referenced each other in a hierarchy three or four layers deep. Certain schemas, entry points and linkbases were permitted in Electronic Data Gathering, Analysis, and Retrieval (EDGAR) filings, some used only internally in EDGAR for validation and rendering, and some used only to provide the "entire" entry point of all files. The growing complexity of published materials — sec.gov/info/edgar/edgartaxonomies.xml, derived web pages such as sec.gov/info/edgar/edgartaxonomies.shtml, interactive data test suites, and applications for analysis and validation -- all pointed to a need for a simplification effort.

As of the 2021 versions of all SEC-maintained XBRL taxonomies, the taxonomy schemas use a simplifying XBRL 2.1 feature documented in the XBRL 2.1 specification section 3.2 and generally referred to as "embedded" linkbases. Any number or type of linkbases may appear in an XML Schema <appinfo> element of an SEC-maintained taxonomy. There are no longer separate linkbase files suffixed ".xml"; all linkbases are now embedded in schemas. In some cases, more than one type of linkbase is embedded in a single schema. Furthermore, only those linkbases that could potentially be used separately from other linkbases in a taxonomy will appear embedded in separate files.

When taxonomies require more than one version in a given year, the four-digit year is augmented with "q2", "q3", or "q4" as the case may be, to indicate the calendar quarter in which it is published.

2 Element Changes and Deprecated Elements

Details about the date, reasons, and relationships between deprecated elements and their replacements are found in the taxonomy entry points having the token **_dep** or **-entire** in them. 3 Specific Changes

3.1 Closed-End Fund (CEF) Taxonomy

The CEF 2021q4 taxonomy removes certain document and entity related concepts from the draft CEF taxonomy version released in April 2020; these concepts are already in the Document and Entity Information (DEI) taxonomy. There are several other deletions, as well as concept additions and modifications, such as changes to concept names, references, and item types.

3.1.1 CEF Concepts Deleted

The CEF 2021q4 taxonomy deletes 28 concepts relative to the April 2020 draft.

3.2 Document and Entity Information (DEI) Taxonomy

DEI 2021q4 modifies references for a number of concepts as compared to DEI 2021, and adds new concepts for tagging auditor information and investment company information. DEI 2021q4 also adds one new item type to accommodate the typical language for uncertain registration dates that is prevalent in registration statements.

3.2.3 DEI Type Added

DEI 2021q4 adds new item type, dateOrAsapItemType, to handle the typical language for uncertain registration dates that is prevalent in registration statements. In a sample of 400 registration statement submissions, only sixteen actually provided a date representing "Approximate Date of Commencement of Proposed Sale to the Public," while all the others had one of the two phrases shown below.
