## 1 Overview

The 2023 draft release updates all SEC-maintained eXtensible Business Reporting Language (XBRL) taxonomies for current and future acceptance in Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system, as shown below. Of the 11 existing taxonomies accepted in EDGAR, this draft release includes additions, modifications, and deletions to the contents for seven taxonomies relative to their prior year versions.

EDGAR is now accepting the 2023 taxonomies, and will subsequently notify the public when it will no longer accept a taxonomy with a double strike-through in the table above. For reference purposes, taxonomy versions in gray and a single strike-through have already been deleted from EDGAR in an earlier release.

If future taxonomies require more than one version in a given year, the four-digit year is augmented with "q2", "q3", or "q4" as the case may be, to indicate the calendar quarter in which it is published.

## 1.2 Synchronization of Taxonomy Version Years

All taxonomies, with the exception of the IFRS taxonomy, within a submission must use the same version year.<sup>1</sup> Quarterly releases within the same version year are also compatible.

*e.g.,* http://xbrl.sec.gov/vip/2022q2 is compatible with https://xbrl.sec.gov/currency/2022 but is not compatible with https://xbrl.sec.gov/currency/2021.

## 2 Element Changes and Deprecated Elements

Detail about the date, reasons, and relationships between deprecated elements and their replacements are found in the taxonomy entry points having the token **\_dep** or **-entire** in them. ## 3 Specific Changes

## 3.1 Closed-End Fund (CEF) Taxonomy

The CEF 2023 taxonomy makes the following changes to its contents relative to CEF 2022 based on our review of the relevant reporting requirements and existing taxonomy elements. Observations of the impact of using the CEF taxonomy within an EDGAR filing of a Financial Statement such as Form 10-K or 10-Q, particularly with respect to Item 4.3 of Form N-2 (Senior Securities), motivated several additional improvements. Improvements appear in several places: (a) in the taxonomy files themselves, (b) EDGAR Filer Manual volume II (EFM) sections 6.12.10 and 6.5.55 validations, (c) the CEF taxonomy guide section on Senior Securities, and (d) updated CEF taxonomy sample files.

#### 3.1.1 CEF 2022 Issues

The figure below shows the disclosure required by Item 4.3 of Form N-2 (Senior Securities). It is similar, and in some cases identical, to the disclosure found in other Inline XBRL formatted EDGAR submissions, sometimes appearing in Item 7 of Form 10-K (Management's Discussion & Analysis, or "MD&A"), sometimes in the Notes to the Financial Statements. To properly include the tagging now required, the submission must refer to a specific file called "the CEF Schema" (cef-2022.xsd).

#### Instructions.

- 1. Instructions 2, 3, and 8 to Item 4.1 also apply to this sub-item.
- Use the method described in Section 18(h) of the Investment Company Act to calculate the
  asset coverage to be set forth in column (3). However, in lieu of expressing asset coverage
  in terms of a ratio, as described in Section 18(h), express it for each class of senior securities
  in terms of dollar amounts per share (in the case of preferred stock) or per \$1,000 of
  indebtedness (in the case of senior indebtedness).
- 3. Column (4) need be included only with respect to senior stock.
- Set forth in a note to the table the method used to determine the averages called for by column (5) (e.g., weighted, monthly, daily, etc.).
- 5. Briefly explain the terms used in the headings of the columns.

**Data Consistency.** The CEF 2022 schema and CEF taxonomy guide require the filer to use a specific element, the "Securities Axis" element, in the Senior Securities table. Other technical constraints that use the validation features of the XBRL Dimensional specification are embedded into the CEF schema, and this is by design for its intended use in Form N-2 filings. However, Senior Securities may consist of either debt or equity instruments, and as seen in Figure 2, information required by column 4 of the Senior Securities table ("Involuntary Liquidating Preference Per Unit") is not applicable to equity instruments. The US-GAAP taxonomy and other guidance has established a convention of distinguishing data items that concern a specific equity instrument (using an element called the "Class of Stock Axis") and those that concern a specific debt instrument (using the "Debt Instrument Axis"). Having two different conventions for tagging the same table of data merely because of the form in which it appears (e.g., using cef:SecurityAxis on a Form N-2 but using us-gaap:ClassOfStockAxis and us-gaap:DebtInstructmentAxis on a Form 10-K) may inadvertently contribute to filer confusion and data inconsistency. Similar issues arise with other elements redundant with those already present in the US-GAAP taxonomy, resulting in substitutions discussed below.

Rendering on SEC.gov. The CEF 2022 schema contains a definition of an object with a three part title, specifically, "995470 - Disclosure - N-2 Item 4, Senior Securities". The format of these titles is governed by EFM 6.7.12; filers are generally free to use any numeric sorting convention at the beginning of the text that they wish, so long as the presentation links follow the approach shown in EFM 6.7.12, where cover pages appear first, followed by statements, followed by "level 1 notes", and so on, as required in Rule 405 of Regulation S-T. Various components of the EDGAR web site display of the rendering also rely on this convention, and also customize aspects of the web display based on whether the filing is considered to be a "Prospectus" as opposed to a "Financial Statement". Inserting the number "995470" into a sequence that filers of financial statements have previously had full flexibility with was not an intended outcome. Indeed, an otherwise valid Inline XBRL 10-K filed today, were it to reference the CEF 2022 taxonomy and tags for the senior securities table, although not suspended, would be very likely to receive a warning.

#### 3.1.2 CEF 2023 separates presentation links from definition links

CEF 2023 partitions its presentation links into a separate "cef-2023\_pre.xsd" file in much the same way that other SEC taxonomies have files for "xyz-2022\_pre.xsd", "xyz-2022\_def.xsd" and so on.

The CEF 2023 taxonomy presentation entry point uses the entry point for simplified rendering ("dei-sub-2023.xsd") and the cef-2023.xsd schema file. Schema file def-2023.xsd embeds definition links for the two us-gaap axes instead of the Security Axis.

The Security Axis and elements listed below have been deprecated. Therefore, filers continuing to use cef-2022.xsd *or* use the Security Axis in cef-2023.xsd will receive a warning message as defined by EFM section 6.5.42 ("Instances should not use elements declared deprecated in any standard namespace").

CEF 2023 deprecates five elements in addition to cef:SecurityAxis and cef:AllSecuritiesMember. Three are replaced by US-GAAP elements, the other two by new CEF elements. The xbrli:periodType attribute changes from duration to instant, for consistency with us-gaap taxonomy modeling conventions.

Finally CEF 2023 adds us-gaap: InterestRateRiskMember as a domain member of cef:RiskAxis. Although there is no corresponding member in CEF 2022, interest rate risk is a commonly disclosed risk, making a custom element unnecessary.

## 4 Appendix: Consolidation of Taxonomy Files

Prior to the 2021 versions of the taxonomies listed in Figure 1 above, every SEC-maintained XBRL taxonomy contained several schemas with element, type and role declarations, empty schemas having only linkbase pointers ("entry points") and linkbases that referenced each other in a hierarchy three or four layers deep. Certain schemas, entry points and linkbases were permitted in EDGAR filings, some used only internally in EDGAR for validation and rendering, and some used only to provide the "entire" entry point of all files. The growing complexity of published materials – sec.gov/info/edgar/edgartaxonomies.xml, derived web pages such as sec.gov/structureddata/dera\_taxonomies, interactive data test suites, and applications for analysis and validation -- all pointed to a need for a simplification effort.

As of the 2021 versions of all SEC-maintained XBRL taxonomies, the taxonomy schemas use a simplifying XBRL 2.1 feature documented in the XBRL 2.1 specification section 3.2 and generally referred to as "embedded" linkbases. Any number or type of linkbases may appear in an XML Schema <appinfo> element of an SEC-maintained taxonomy. There are no longer separate linkbase files suffixed ".xml"; all linkbases are now embedded in schemas. In some cases, more than one type of linkbase is embedded in a single schema. Furthermore, only those linkbases that could potentially be used separately from other linkbases in a taxonomy will appear embedded in separate files.
