1 Overview

The 2024 release updates all SEC-maintained eXtensible Business Reporting Language (XBRL) taxonomies for current and future acceptance in Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system, as shown below. Of the 17 SEC-maintained XBRL taxonomies accepted in EDGAR, this release includes additions, modifications, and deletions to the contents for seven taxonomies relative to their prior year versions.

The Commission will notify the public as to when EDGAR will begin accepting the 2024 taxonomies, and subsequently, when it will no longer accept a taxonomy with a double strike-through in the table above. As the table indicates, both the 2024 and 2023 taxonomy versions will be accepted in EDGAR. For reference purposes, taxonomy versions in gray and a single strike-through have already been deleted from EDGAR in an earlier release.

1.2 Synchronization of Taxonomy Version Years

All taxonomies within a submission must use the same version year. Quarterly releases within the same version year are also compatible.

If a filer also discloses an arrangement's expiration date as a material term of a trading arrangement, the filer must also use the new [TrdArrExpirationDate] concept.
